1. Policy

1.1 Policy Statement

Our school is committed to promoting excellent attendance and punctuality to ensure all pupils can achieve their full potential. Regular attendance supports pupils' learning, wellbeing, and safeguarding.

We work in partnership with parents/carers to promote high attendance and will monitor attendance closely, identifying and addressing any concerns at an early stage.

1.2 Terms and Definitions

The below table sets out a number of terms and definitions used within this document:

Term	Definition
Parents	Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including: Natural or adoptive parents, adults with parental responsibility and/ or Those who have day-to-day responsibility for the child (i.e. lives with and looks after them).

1.3 Data Protection

The Five Rivers Group supports the objectives of the United Kingdom General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018 (DPA 2018) and other legislation relating to Data Processing, including the Human Rights Act 1998, the Safeguarding of Vulnerable Groups Act 2006 and the regulations that underpin our services. The Five Rivers Group has a statutory obligation to process personal data in accordance with the provisions of the United Kingdom General Data Protection Regulation (UKGDPR) and the Data Protection Act 2018.

Every member of The Five Rivers Group has an obligation to ensure that the information they process (use) is collected, maintained and disclosed in accordance with the United Kingdom General Data Protection Regulation (UKGDPR), the Data Protection Act 2018, the Five Rivers Group Data Protection Policy and The Five Rivers Group Data Retention Policy.

1.4 Disclosure of Information

It is a criminal offence for a person to knowingly or recklessly sell, disclose or retain personal information outside of the Five Rivers Group under section 170 DPA 2018 without a legitimate purpose and legal basis. The Five Rivers Group considers these actions unauthorised and will take all necessary action to ensure personal data is not disclosed, retained or sold without a valid legal reason including referral to the criminal investigations team of the information commissioner's office (CRIT ICO).

2. Aims

This policy demonstrates our commitment to meeting our statutory obligations with regards to school attendance, in line with the Department for Education's (DfE's) [Working together to improve school attendance](#).

We aim to:

- Set high expectations for the attendance and punctuality of all pupils
- Promote good attendance
- Identify, monitor and reduce absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Act early to address patterns of absence and remove barriers
- Work in partnership with parents/carers, local authorities and external agencies
- Ensure attendance is treated as a safeguarding priority.

We will also promote and support punctuality in attending lessons.

3. Legislation and guidance

This policy complies with:

- DfE Statutory Guidance (2026): Working Together to Improve School Attendance
- School Attendance (Pupil Registration) (England) Regulations 2024
- Education Act 1996 (Part 6) – parental duty for education
- Education and Inspections Act 2006
- Keeping Children Safe in Education (KCSIE 2026)
- Summary of responsibilities where a Mental Health issue is affecting attendance
- Equality Act 2010

Schools have a legal duty to:

- Maintain accurate attendance registers
- Share data with the local authority and DfE

4. Roles and responsibilities

4.1 The Board of Directors and Head of Education

The Board of Directors and Head of Education are responsible for:

- Setting high expectations of all school leaders, staff, pupils and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authority
 - Making sure the school works effectively with local partners to help remove barriers to attendance, and keeps them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the school's policies and ethos
- Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for pupils in need by prioritising staff and resources
- Making sure the school has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- Regularly reviews and challenges attendance data and helping school leaders focus improvement efforts on individual pupils or cohorts who need it most
- Working with school leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - The school's legal requirements for keeping registers
 - The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
- Holding the Head of Education and Headteachers to account for the implementation of this policy

4.2 The Headteacher

The headteacher is responsible for:

- The implementation of this policy at the school, ensuring a whole school attendance strategy is implemented .
- Monitoring school-level absence data and reporting it to the Head of Education
- Supporting staff with monitoring the attendance of individual pupils
- Ensuring accurate recording of attendance and the new attendance codes
- Monitoring the impact of any implemented attendance strategies
- Working with the parents and carers of pupils with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for pupils with SEND, including where school transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the pupil's needs
- Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents and carers through all available channels

4.3 The school's leadership team

The school's leadership team are responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with pupils, parents/carers and external agencies, where needed
- Building close and productive relationships with parents and carers to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families
- Monitoring and analysing attendance data
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports to school staff and reporting concerns about attendance to the Headteacher.

4.4 The school's Business Administrator

The school's Business Administrator must ensure registers are completed twice daily and within required timescales. Correct codes must be used (see Appendix 1). They will ensure data is accurate, timely and auditbale in line with DfE expectations.

Business Administrators take calls from parents/carers about absence on a day-to-day basis and will record this on Arbor.

4.5 Parents

Parents have a legal duty to ensure their child attends school regularly.

Parents must call the school to report their child's absence before their start time on the day of the absence and each subsequent day of absence, and advise when they are expected to return. An alternative option is to record on Arbor via the parent portal.

Parents will provide the school with 2 emergency contact numbers for their child

Parents will ensure that, where possible, appointments for their child are made outside of the school day.

Parents will seek support, where necessary, for maintaining good attendance, by contacting the school.

4.6 Pupils

Pupils are expected to:

- Attend every timetabled session, on time

5. Recording attendance

5.1 Attendance register

Attendance will be recorded on Arbor in line with the national codes.

Registers must be taken:

- at the start of the first session each day
- at the start of the afternoon session each day

Schools must determine the reason for an absence within 5 working days.

Any amendment to the attendance register must include an audit trail with;

- The original entry
- The amended entry
- The reason for the amendment

- The date on which the amendment was made
- The name and position of the person who made the amendment

Attendance records must be retained for a minimum of 6 years.

See Appendix 1 for the DfE attendance codes.

5.2 Unplanned absence

The pupil's parent/carer must notify the school of the reason for the absence on the first day of an unplanned absence before the school day starts or as soon as practically possible, by calling the school. An alternative option is to record on Arbor via the parent portal.

We will mark absence due to physical or mental illness as authorised (code I), unless the school has a genuine concern about the authenticity of the illness.

Where the absence is longer than 5 days, or there are doubts about the authenticity of the illness, the school will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised (Code O) and parents will be notified of this in advance.

If a pupil does not arrive for school, contact with all emergency contacts will be attempted in the first instance. A home visit or welfare check may be carried out. Safeguarding procedures will be followed in line with KCSIE.

If absence continues, the school will consider involving an education welfare officer.

The school will identify whether the pupil needs support from wider agencies, as quickly as possible, and make the necessary referrals.

Where support is not appropriate, not successful, or not engaged with, their school placement will be reviewed.

5.3 Planned absence

Attending a medical or dental appointment will be counted as authorised (Code M) as long as the pupil's parent notifies the school in advance of the appointment via email.

However, we encourage parents to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

Leave of absence during term time will only be authorised in exceptional circumstances, such as:

- Serious family emergency
- Significant welfare concerns

The school may request evidence and will make decisions on a case-by-case basis.

We are not able to authorise family holidays.

5.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code (Code L)
- After the register has closed will be marked as absent, using the appropriate code (Code U)

6. Strategies for promoting attendance

Our schools will include attendance within their behaviour and reward system, if we feel like this is needed.

- Individual attendance plans for students with persistent absence.
- Flexible timetables or phased returns where appropriate.
- Daily check-ins with key staff members.
- Home visits or welfare calls if contact is not made.
- Multi-agency collaboration (e.g., CAMHS, social care, EWO).

7. Supporting pupils who are absent or returning to school

7.1 Pupils absent due to complex barriers to attendance, mental or physical ill health or SEND

We do everything we can to support families and pupils with complex barriers to attendance. Our school strength is supporting pupils back to education. We will provide a bespoke package around the child and work on an appropriate transition plan. This will be monitored and reviewed regularly. We hold a minimum of bi-weekly safeguarding meetings and long term absence is discussed when appropriate and necessary. Absence will always be considered a potential safeguarding concern.

Where a pupil has an education health and care (EHC) plan and their attendance falls, or we become aware of barriers to attendance that are related to the pupil's needs, we will inform the local authority.

7.2 Pupils returning to school after a lengthy or unavoidable period of absence

We will:

- Use attendance data to find patterns and trends of persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education

- Hold regular meetings with parents of pupils who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - Discuss attendance and engagement at school
 - Listen, and understand barriers to attendance
 - Explain the help that is available
 - Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant
- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these pupils. In doing so, the school will sensitively consider some of the reasons for absence

8. Attendance monitoring

8.1 Monitoring and analysing attendance

The school will monitor and analyse attendance and absence data (including punctuality) monthly, termly and yearly across the school and at an individual pupil level.

Data will be collected each month and reported to the Head of Education.

The school will identify and record pupils whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence.

9. Use of Part-Time Timetables

9.1 Working Together to Improve School Attendance, July 2026:

It is important to highlight that there is no statutory basis upon which to establish a reduced timetable. Ofsted have made it clear that this must be in the interests of the child and not the school.

The Department for Education guidance, 'Working together to improve school attendance' states:

"All pupils of compulsory school age are entitled to a full-time education. In very exceptional circumstances, where it is in a pupil's best interests, there may be a need for a school to provide a pupil of compulsory school age with less than full-time education through a temporary part-time timetable to meet their individual needs. For example, where a medical condition prevents a pupil from attending

school or another setting full-time, and a part-time timetable is used to help the pupil access as much education as possible. A part-time timetable should not be used to manage a pupil's behaviour."

"A part-time timetable should:

- Have the agreement of both the school and the parent the pupil normally lives with.*
- Have a clear ambition and be part of the pupil's wider support, health care or reintegration plan.*
- Have regular review dates which include the pupil and their parents to ensure it is only in place for the shortest time necessary.*
- Have a proposed end date that takes into account the circumstances of the pupil, after which the pupil is expected to attend full-time, either at school or alternative provision. It can, however, be extended as part of the regular review process. In some limited cases, a pupil with a long-term health condition may require a parttime timetable for a prolonged period."*

In addition, it is recognised that reintegration following a prolonged period of absence is an appropriate reason for a part-time timetable.

The risks for pupils associated with reduced attendance at school for whatever reason, including a temporarily reduced timetable, are well researched. These include the risk of sexual or other exploitation, or other safeguarding risks as well as the risk of lower educational attainment.

When considering a part-time timetable, schools must consider the safety and wellbeing of the pupil in terms of whether a reduced educational offer would increase their vulnerability and place them more at risk of potential harm.

We consider this but are aware that our pupils have often not been attending at all so historically have been placed at the greatest risk. By starting education, even on a part time basis, we are consequently reducing that risk. It is important to note that our schools are consistently working with pupils in 'exceptional circumstances'.

Our pupils often arrive at school with a history of significant non-attendance and emotionally based school avoidance. Many of them will have experienced multiple placement breakdowns in their education placements as well as their home. School has no longer become a safe space for them but rather leads to feelings of shame and failure. It is our role to rebuild trusting relationships with pupils through creating an environment of 'High Structure /High Nurture'. We take the view that the best way to build their attendance can be to grow their timetable gradually ensuring confidence at each step of their journey.

Our pupils have a varied and bespoke timetable and are not always on school site, however they are always supervised by our staff on these regular timetabled activities, and will be marked using the B code. If they are at an Alternative Provider without our staff, they will also be marked as a B code. There will be a clear narrative on the register as to where they are being educated.

Where a part time timetable is to be used, we agree this at point of admission with the Local Authority and the parent. If there is a need for a part-time timetable post admission this would again be done in consultation and agreement with the parent/carers and the Local Authority.

Part time timetables must be:

- Timely
- Formally agreed with parents and LA
- Regularly reviewed (externally every half term, internally every 2 weeks as part of the bi-weekly safeguarding meeting)

On roll students will be recorded on the part time tracking and monitoring document. Any students on a 1ACE commissioned package will be added to the part time tracker if they are timetabled less than 20 hours. The part time tracking and monitoring document will be stored in the Business Support Attendance folder on SharePoint and include the low attendance log.

9.2 Responsibility for children when not attending school, including Safeguarding role:

When a pupil is placed on a part-time timetable the parents/carers are responsible for supervision of the pupil during the hours when not attending school. However, we recognise that schools have a safeguarding responsibility for all pupils on their roll and therefore must be aware that even with parental agreement to any arrangement they make, they are responsible for the safeguarding and welfare of pupils off-site during school hours.

We support this through close communication with parents and carers and welfare calls on days when the child is not due to attend.

In addition to children placed on the roll of our schools, we also work with children on an Alternative Provision (AP) basis. This can be face to face, virtually or Hybrid (a combination of the two). AP placements are normally commissioned directly by the Local Authority (or sometimes a school). These will be for a specified number of hours per week and are always of a part-time nature. The same principles regarding agreement of a part time timetable will be followed.

In this instance we only hold safeguarding responsibility for the hours of their specified programme.

10. Attendance Champions

All our schools have an Attendance Champion on the School's Leadership Team, they are also part of the Safeguarding team. The Attendance Champion will meet with the School's Business Support once a month to review pupil's individual attendance and whole school attendance. The Attendance Champions responsibilities are:

- To set a clear vision for improving and maintaining good attendance.
- Establish and maintain effective systems for tackling absence.
- Regularly monitor and evaluate progress and analyse attendance and absence data to identify pupils that require support with their attendance and put effective strategies in place. This will be recorded on the low attendance log, saved in the Business Support Attendance folder.
- Be particularly mindful of pupils absent from school due to mental or physical ill health or their special educational needs and/or disabilities, and provide them with additional support.
- Review attendance data half termly, termly and full year to identify patterns and trends relating to attendance.
- Communicate with the Headteacher to notify their Local Authorities if there are attendance concerns.
- Liaise with Business Support to raise any actions relating to low attendance in line with our school attendance policy. Eg, send out low attendance letter to parents/carers.

The attendance Champion will also be the main point of contact for parents/carers to discuss any barriers their child faces in relation to attending school and any support they may require.

11. Monitoring arrangements

This policy will be reviewed as guidance from the local authority and/or DfE is updated annually.
